Planning Board Report - Miss Skinner

Miss Skinner advised the members that the following issues were discussed at the Planning Board meeting:

By-Laws

The members discussed unexcused absences. The Chairman said that he would draft a copy of the By-Laws that will address the unexcused absences.

Cyr Lumber

The Chairman explained that the Commission received an invoice from Cyr Lumber in the amount of \$763.31 for the purchase of pressure treated lumber. Mr. Wayne Morris advised the Chairman that the Commission will be receiving an updated invoice from Cyr Lumber in the amount of \$1099.00. Mr. Anderson motioned and Mr. Senibaldi seconded the motion to spend \$1500.00 from the Conservation Land Fund to complete the construction of the bridges.
