Conservation Commission Minutes <u>June 8, 2006</u>

Seat Alternates

The Chairman appointed Mr. Rouillard and Mr. Morris to fill the two empty seats for this meeting.

Spruce Pond II – Joe Maynard of Benchmark Engineering, Representing H&B Homes

Mr. Maynard explained that he received a variance to use the front portion of land for open space but will be going back to the Zoning Board because he only wanted one lot not the entire parcel used for open space. H&B Homes will be buying one parcel that borders Mitchell Pond and incorporating it into the project as additional open space. The ordinance allows 30,000 square foot lots in an open space subdivision but Mr. Maynard is planning these lots to be 1-acre in size. Mr. Maynard will return for another meeting with the Conservation Commission regarding Spruce Pond II to show wetland impacts and to schedule a site walk. Mr. Morris said that there are great trails on this 12-acre parcel and it would be a shame and he would be disappointed to see a house built on that particular parcel. Mr. Morris asked Mr. Maynard if he had support to preserve that piece of land plus the 12-acres would that make a difference. That is the only corridor left in town H&B Homes has made a verbal commitment to the Windham Rail Trail to donate \$50,000.00.

High Pointe East - Planning Board Request for Comments

This parcel crosses the railroad bed off of Ironwood Road. After looking at the submitted plan the Commission stated that the plan cannot be followed. Miss Skinner said that the engineer pulled the plan from the Planning Board agenda.

Approval of May 25, 2006 Minutes

Miss Skinner motioned and Mr. Morris seconded the motion to accept the May 25, 2006 minutes as written. Passed unanimously 4-0.

Because it was not mentioned in the motion made at the May 25, 2006 meeting to purchase lot 8-B-4200 Miss Skinner motioned to approve the purchase the 27 acres on Lot 8-B-4200 known as the Rau property. Mr. Morris seconded the motion. Passed unanimously 4-0.

Lot 8-A-52, 19 Seavey Road

The abutter to 19 Seavey Road would like to purchase this property. The Commission agreed to allow the sale with the stipulations that the two lots be combined into one and the existing building be removed and not used as another building lot.

Mr. Morris reported his conversation with Luke Hurley of Gove Environmental asking that Jim Gove attend a meeting and discuss gravel wetlands and incorporating this into site plan and subdivision regulations.
