<u>Common Man Restaurant – Karl Dubay of MHF Design</u>

Restaurant Reconstruction

Mr. Alex Ray, owner of the Common Man Restaurant, explained that the New Hampshire Department of Transportation decided to move the highway (Route 93) another 60' west.

Mr. Dubay, representing the applicant, presented the conceptual package and explained that the existing rear parking area will be removed and the parking will be reconfigured. There will be a small addition for a new entry way, kitchen and increased seating capacity. There are no wetland impacts. Mr. Dubay discussed current and proposed septic systems with the Members and the possibility of facing a retaining wall with stone or other natural materials. Mr. Dubay said that he will return to the Conservation Commission at a later date with a final design and asked for a letter of support from the Commission regarding the conceptual plan. Mr. Dubay needs this letter within the next week and a half. Mr. Morris motioned and Miss Skinner seconded the motion that the Commission favors the conceptual plan presented tonight. Motion passed 5-0.
