Seat Alternates

Mr. Rouillard replaced Dr. Anderson and Mr. Morris replaced Dr. Finn for this meeting.

Replacement of Castle Hill Road Bridge over Beaver Brook - Dredge & Fill

Estimated area to be filled – 1100 square feet

Estimated total area of proposed work in Wetlands Bureau jurisdiction -3200 square feet Average length of Shoreline Frontage -190 feet

The town of Windham is seeking to replace the existing one-lane timber deck and timber stringer bridge. The proposed bridge provides two, 10-foot travel lanes with 2-foot shoulders and on-bridge guard rail providing 24' road width between bridge rails. The project also includes road widening and guardrail installation within the project limits.

After a brief discussion, the Members scheduled a site walk for Saturday, April 26, 2008 at 8:00 AM. Comments will be given at the next scheduled meeting after the site walk.

<u>Farmland Preservation Initiative – Mr. Morris</u>

Mr. Morris advised that photos of three Windham farms are on the town website and the fourth farm will be added soon.

Mr. Morris explained that he spoke with Mr. & Mrs. Nassar about the possibility of purchasing Apple Acres. Mr. Nassar wanted to meet with the Conservation Commission to see if there is support from the Commission regarding the possibility of purchasing Apple Acres and to discuss the process.

Mr. Nassar explained that he has a partially complete subdivision and a road under construction. It doesn't make sense to build a road if the Town wants to buy the property. It would be important to see a formal vote or letter to take to other boards explaining that a purchase may go forward or there is a "stand still" agreement. Mr. Nassar was concerned about permits expiring. Mr. Nassar wants it to be in the record that this discussion took place and this is a legitimate possibility for him to consider.

Mr. Rouillard motioned and Mr. Morris seconded the motion that the Conservation Commission is supportive of having active conversations with Mr. Nassar and other farm owners. Motion passed 4-0.

Other Business

Mr. Morris thanked Dr. Finn for all the work he put into applying for the Water Supply Land Grant that was awarded to the Town of Windham by the New Hampshire Department of Environmental Services. Windham will receive \$190,000.00.

Review of Zoning Board Cases

Lot #21-K-33, Case #31-2008

Applicant – Brad & Mariann Bemister Owner – Brad & Mariann Bemister Location – 58 Turtle Rock Road` Zone – Residential A

A variance is requested from Section(s) 401, 405.2 & 702 Appendix A-1, of the Zoning Ordinance to permit the enclosure of a deck with roof and screens with a side setback of 24' where 30' is required, a front setback of 30' where 50' is required and a rear setback of 30' where 50' is required and a street setback of 100' where 175' is required.

After reviewing Case #31-2008 the Commission said that this request violates the Shoreland Protection Act. Mr. Rouillard requested that a letter be sent to the Zoning Board of Adjustment stating the concerns of the Conservation Commission.
