Conservation Commission Minutes <u>February 12, 2009</u>

CVS Pharmacy, Lot #11-C-701, 1 Wall Street

Mr. Peter Zohdi of Herbert Associates and Mr. Bryant Anderson, Project Engineer of Vanasse Hangen Brustlin, Inc. presented the plan. Mr. Zohdi submitted site plans and explained that a 13,600 square foot pharmacy along with an 18,000 square foot, two-floor commercial building is proposed for the 4.22 acre lot at the existing NHDOT Park & Ride site. There are no wetland or WWPD impacts. Variances were granted on September 23, 2008.

Mr. Bryant Anderson explained that there will be underground storage for drainage. There is an existing drainage system under the Park & Ride. Currently there is a 24" drain line along Wall Street. The proposed drainage collection system will include catch basins, drain pipes and the water will then be routed through water quality units for treatment. There will be three water quality units with arched open bottom chambers. The water will be discharged through a 12" pipe culvert under Route 111.

The Commission questioned the efficiency of the storm water system. Mr. Morris commented that the system presented is an improvement to what exists.

Mr. Zohdi requested a letter of recommendation from the Conservation Commission be sent to the Planning Board before March 4, 2009.

Mr. Morris motioned and Miss Skinner seconded the motion that the Chairman write a letter of recommendation to the Planning Board. Motion passed 5-0.
