### **Speed Limits –**

Committee discussed the lowering of speed limits to 25 mph from previous meeting. Committee will be reviewing these in the future. G. Lewis handed the committee information regarding this information as well as RSA's governing the lowering of speed limits. Committee agreed to move forward with letter to Selectmen requesting a list of roads in which they voted to lower the speed to 25 mph without any study or investigation.

# Collins Brook Road Parking Issue -

Committee discussed their visits to Collins Brook Road. Discussion ensued regarding the current 26 foot wide roadway and what impact the snow banking have on the passageway. Committee also discussed how school events contribute to the parking along the road.

Lewis requested to amend motion to include a request of the Department of Transportation to place additional "No Parking" signs 50 feet north and south on the easterly side of Lowell Road so as to not impede the line of site coming out of Collins Brook Road and to look at the possibility of additional signage along the westerly side of Lowell Road to 50 feet beyond the most southerly driveway of Center School. T. McPherson will formulate letter to Board of Selectmen.

Passed unanimously.
