- Mr. McLeod motioned to approve the August 18 minutes. Mr. LoChiatto seconded. Passed 6-0;
- Mr. McLeod motioned to approve the August 25 minutes. Mr. Kolodziej seconded. Passed 6-0.

- Timberland Road Ext, bond release of \$83,508 and retain \$219,303.60. Mr. McLeod motioned to grant. Mr. Kolodziej seconded. Passed 5-0-1. Mr. Breton abstained;
- Heritage Hill Road Ext, bond release of \$318,248.40and retain \$38,388. Ms. Skinner motioned to grant. Mr. LoChiatto seconded. Passed 5-0-1. Mr. Breton abstained;
- Rogers Auto Body, bond release of \$4,200. Mr. LoChiatto motioned to grant. Mr. Kolodziej seconded. Passed 6-0-1. Mr. Breton abstained.

Mr. McLeod motioned to accept the withdrawal of 90 Indian Rock Road site plan from the agenda. Mr. Breton seconded. Passed 6-0.

PUBLIC HEARINGS:

<u>Harris Road Lot Line Adjustment (13-B-94, 13-B-95, and 13-B-60) – Public Hearing</u> 26 & 28 Harris Road and 24 Rockingham Road

Mr. Turner reviewed letters from: 1) Attorney Mason, and 2) Attorney Campbell. He then reviewed the Board's options regarding the plan. Attorney Mason discussed the background of the property, improper subdivision, variance, and purchase and sale agreement. Attorney Matt Johnson, representing Wayne and Margaret Allfrey, request to the Planning Board hear the lot line adjustment, and civil matter between owners.

Mr. Turner stated the application is in compliance with the waivers if granted and recommends for public hearing. Mr. McLeod motioned to accept for public hearing. Mr. Kolodziej seconded. Discussion ensued regarding Attorney Campbell's recommendations, and owner authorization. Ms. Valerie Tobin, Skylight Industries, discussed the variance, right-of-way, and ownership. Attorney Mason discussed the conditions of the variance, and new purchaser's intent.

Mr. McLeod motioned to accept the Harris Road lot line adjustment site plan for public hearing in light of staff's and Attorney Campbell's comments. Failed 1-5. Ms. Maloney, Mr. Kolodziej, Mr. LoChiatto, Ms. Skinner, and Mr. Breton opposed.

Mr. Breton motion to table until September 15 at 8:00 pm so that staff and the involved counsels can discuss and ascertain the facts of ownership. Mr. Kolodziej seconded. Passed 5-1. Mr. McLeod opposed.

Mr. McLeod motioned to adjourn. Mr. Kolodziej seconded. Passed 6-0 Meeting adjourned 9:15 pm. Passed 6-0.
