PUBLIC MATTERS:

Recreation Master Plan Update:

Ms. Haas: The Recreation Master Plan Committee has been working on the Master Plan since January. The committee is comprised of herself and the following 5 volunteers: Chris O'Neil, Bill Brennan, John LaRochelle, Ralph Valentine, and Mike Hatem. A 50/50 grant was received through the Rockingham Planning Commission (RPC). The committee worked from and expanded on the four strategies in the Town Master Plan. Strategy 1, to inventory and assess existing recreation facilities in Town, has been completed and RPC is currently developing maps. Strategy 2, to estimate current and future recreation program needs, is in progress. The data is based on a Town survey and future projections with consideration being given to active and passive recreation. RPC is contracted through June 30 and is tasked with Strategies 3 and 4, estimating the need for additional facilities and estimating the costs for both new facilities and long-term maintenance costs for the existing recreation facilities town-wide. *Mr. Kolodziej joined the Board*.

Board discussion included impact fees, CIP process, and length of time to complete the Recreation Master Plan. The committee can utilize Planning Staff and the BOS to communicate with RPC, and Planning Staff and Planning Board for input and advice. The committee will provide copies of Strategies 1 and 2 for Planning Board review.

Mr. Kolodziej motioned to adjourn. Mr. LoChiatto seconded. Passed 7-0. Meeting adjourned at 8:00 pm.
