#### **Old Business**

There was a great deal of discussion on the priority list. The Recreation Coordinator noted that she and Mr. Barlow are unable to find anyone to sift the sand prior to the new sand being spread. Mr. Bartlett suggested to hire some local students to sift the sand.

There was a great deal of discussion on Tokenal Field. Mr. Hatem was interested in finding out if the Recreation Committee was moving forward or not with repairing the field. Mr. Valentine felt that before making a decision, it was important to have concrete prices on what the repairs would cost. He also felt that it was important to have engineering completed on the field before doing any work. Mr. Bartlett made a motion for the Recreation Committee to expend up to \$15,000 for the repair and restoration of Tokenal Field pending bids in the correct price range in conjunction with a donation of \$10,000 from Michael Hatem from WBSL, with the entire bid no to exceed \$25,000 in total. Brian Carne seconded; the vote passes 4-1 (Mr. Valentine opposed.)

Mrs. Haas will work with Mrs. Lippold on planning Town Day on July 2, 2006.

The meeting adjourned at 9 pm.
