#### **Recreation Coordinator Updates:**

- Parking Lot at Griffin Park
  - o CPIA to review plans with Peter Zhodi
  - o Plans are out for bid
  - o Ms. Haas will keep the committee updated on the project
- Summer Programs
  - o Programs are full and going well
- Aug Meeting
  - Should focus on upcoming Budget meetings
    - Look at maintenance projects and priorities
- Senior Picnic

## Town Beach

## o Raft

- The raft was flipped upside down and sustained damage
- Received assistance for the Windham FD since it couldn't be righted
- Pontoons took on water and need to be checked
- Raft is 15 years old and the committee may want to think about replacing it.

## o <u>Parking</u>

- Still many out of state plates in the parking lot
- Blocking / parking in front of the fire access
- Discussion about surveillance cameras and if it made sense to look into this further
  - Mr. Senibaldi noted the Transfer Station has old equipment that may be an option if the committee wanted to pursue.

# o CPIA Water Ski Show

- Event is scheduled for Aug 20<sup>th</sup>
- The Town beach is used as viewing area as well as the staging area for the Emcee/DJ
- Ms. Haas brought up safety concerns
  - lifeguards have a hard time hearing anything due to the event
  - Location of the Emcee/DJ on the concrete pad blocks the path of the lifeguards that are in the block house
- Mr. Senibaldi suggested using an air horn in case of emergency
- Look into using a Park Ranger for the event
- CPIA will work with ms Haas for a solution

#### Skate Park

- A meeting was held on July 8<sup>th</sup> at the Skate Park to determine the condition. Those in attendance Ralph Valentine, Tim Kelleher, Cheryl Haas and Mike Loiselle
- They determined the following
  - o 150 sheets total
  - o Aprox. 115 have been replaced
  - o 35 more need to be replaced due to poor condition
- Currently we own 6 sheets and would need 29 more to complete the project.
- The Recreation Committee has money in the budget to cover the repairs

Motion was made by Dennis Senibaldi and seconded by Chris O'Neil;

To spend up to \$6,000 to purchase the remaining 29 sheets and have all 35 sheets installed this year at the skate park. **Motion passed 5-0-1,** Lynn Goldman stepped out of the meeting prior to the vote

- Mr. Senibaldi working on Spruce Pond packet and will be ready prior to the CIP meeting
