### TOWN RECOMMENDATIONS

Chairman R. Valentine brought in a draft letter for committee to review. Committee spent bulk of meeting discussing recommendations for actions on specific lots of land owned by town. After much discussion about best property use, definition of "right of way", "value of property to town", and some very constructive comments from members: A. Letizio, R. Valentine, B. Higgins, P. Gosselin, E. Gallagher and CDD Laura Scott the committee was in agreement on the following recommendations:

M. Oldenberg made motion to make recommendations on lots, seconded by C. Roberts

Lot 8B 850, Lot 8B 900: Keep (looked at as potential fire substation use)
Lot 8B 1860, 11A 634: Keep (WEDC would like further evidence and definition of why "right of way" is listed in description of lot). Historically this language has very specific meaning when looking at lots.

Lot 9A 652: Merge with 9a 655 and sell

**Lot 16L 50**: Keep

Lot 8B 4401: Discontinue Libby Road and offer parcel to abutter along Libby

Road.

Lot 8B 6301: Keep

Lot 9A 655: Merge with 9A 652 and sell

Lot 11A 298: Keep Lot 11C 350: Keep

Lot 14A 230: Conservation

**Lot 20D 1000**: Keep
